GENERAL BUSINESS

Remember that all Affiliates and Clubs are required to submit approval for all their shows and clinics to HSAA one month prior to the event. Show Approval Forms have been attached.

Whenever possible please use HSAA and AQHA judges in order to meet with insurance requirement. It is suggested that Affiliates put this in their show conditions: Any person riding on the grounds regardless of whether they are competing must pay a day fee and sign a waiver otherwise they are not covered by insurance.

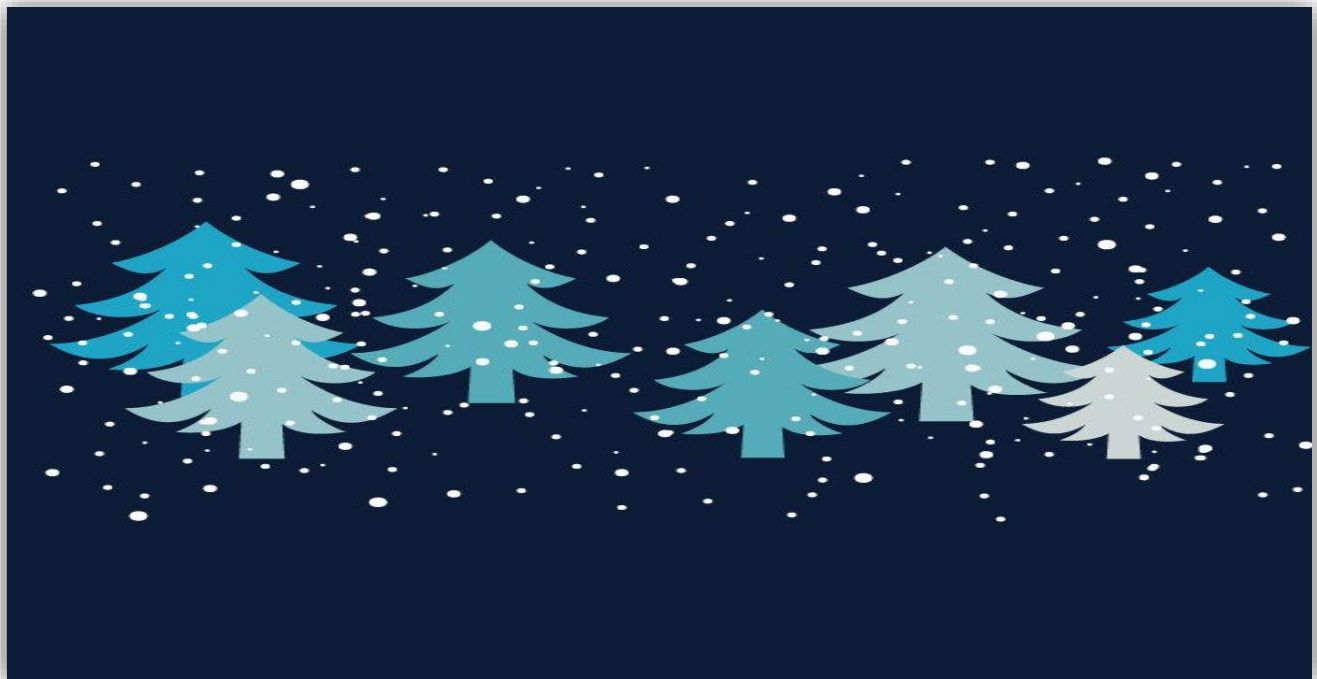
